1. <u>Purpose:</u>

The purpose of this Data Protection Policy is to ensure that **Hopes Safety Consultancy LLC SPC**, complies with applicable data protection laws and regulations. The policy is designed to protect the personal data of employees, clients, trainees, and other stakeholders, ensuring confidentiality, integrity, and accountability in all data processing activities.

2. <u>Scope:</u>

This policy applies to all employees, contractors, and stakeholders of **Hopes Safety Consultancy LLC SPC** Training Center who process or handle personal data. It covers all personal data collected, stored, and processed in both digital and physical formats.

3. Definitions:

- Any information relating to an identified or identifiable individual, including names, contact details, identification numbers, or any other data that can be linked to a specific person.
- The individual whose personal data is being processed.
- Any operation performed on personal data, such as collection, storage, use, transfer, or deletion.
- Hopes Safety Consultancy LLC SPC, which determines the purposes and means of processing personal data.

4. Principles:

Hopes Safety Consultancy LLC SPC adheres to the following principles when processing personal data:

- Data is processed lawfully, fairly, and in a transparent manner.
- Data is collected for specific, explicit, and legitimate purposes and not further processed in a manner incompatible with those purposes.
- Only the data necessary for the intended purpose is collected and processed.
- Data is kept accurate and up-to-date.
- Data is retained only for as long as necessary for the purposes for which it was collected.
- Data is processed securely to prevent unauthorized access, loss, or damage.

8. Data subjects have the following rights regarding their personal data:


- Request access to their personal data.
